

- Your most recent liquor licence or BYO permit must be displayed in a conspicuous place on the licensed premises in a manner that invites public attention. Failure to do so may result in a penalty exceeding \$500.
- The licence is valid until the end of each calendar year.
- This is the holder of the licence. The licensee can be a company, partnership, individual or a club.
- This is your postal address and should be kept up to date. Please notify the Victorian Commission for Gambling and Liquor Regulation (VCGLR) of any changes on 1300 182 457.
- States the type of licence and the circumstances under which the licensee is authorised to supply liquor.
- All liquor licences have conditions to ensure that the operation of the business does not cause undue detriment to the amenity of the area.
- This specifies your liquor trading days and hours Note: Patrons have a 30 minute grace period to finish drinks purchased prior to the end of trading hours (no alcohol is to be sold during this time).

This licence is a restaurant and cafe licence and authorises the licensee to supply-liquor on the licensed premises for consumption on the licensed premises during the trading hours specified below.

RESTAURANT & CAFE CONDITIONS

This licence is subject to the following conditions

the predominant activity carried out at all times on the premises must be the preparation and serving of meals for consumption on the licensed premises: and

tables and chairs must be placed in position on the licensed premises so as to be available for at least 75% of the patrons attending the premises at any one time; and

the licensee must not permit -

the live performance of any musical works; or

the playing of any recorded musical works -

on the premises at higher than background music level at any time outside ordinary trading hours.

Condition (c) does not apply to music performed or played on the licensed premises outside ordinary trading hours as part of a function that is held in an area of the premises that is set aside for the exclusive use of persons who have booked a table in that area and their guests, and is attended only by those persons and their guests.

The licensee shall not cause or permit undue detriment to the amenity of the area to arise out of or in connection with the use of the premises to which the licence relates during or immediately after the trading hours authorised under this licence.

The licensee shall ensure that the level of noise emitted from the licensed premises shall not exceed the permissible noise levels for

entertainment noise as specified in the State Environment Protection Policy (Control of Music Noise from Public Premises) No.N-2.

The windows facing Williams Street are to be shut and remain shut after 9 p.m. on any day.

- This changes annually.
- If you need to contact the VCGLR, it will assist if you quote your licence number.
- The name the business trades under. Please notify the VCGLR if you change your trading name.
- The actual location of your licensed premises.
- A nominee is a person nominated by a licensee or permittee and approved by the VCGLR. They assume the responsibilities and obligations of the licensee/permittee.
- As well as your general obligations, you will have conditions listed on your licence that are directed specifically at your premises. You need to comply with these conditions or you will be committing an offence. The conditions listed here are an example of the conditions that apply to a restaurant and cafe licence. Licensees can apply to the VCGLR to vary their conditions. Details are available at our website listed below.
- You may apply to the VCGLR for endorsement of additional approvals on your licence. For example, you may have approval to supply alcohol in an additional area (foothpath trading).
