# How to register your account

- 1. Register an account in the Wholesale sales data reporting portal using the below link: <u>https://liquor.vcglr.vic.gov.au/iAlarmWholesalesOnline/</u>.
- 2. Select 'Register' in the menu on the left side of the screen.



3. Fill in your details and choose a password.

Note: the password must be more than 6 characters and include 1 upper case, 1 lower case and 1 numeric character.

### How to Associate Liquor Licence

1. Log into the wholesale sales data reporting portal. Click on 'Add/Associate a Licence'.



2. Enter in the licence number and the postcode of the licence postal address. Complete '**I'm not a robot**' as per steps 4 and 5 in the above registration instructions. Once these three fields have been completed click on '**Associate**' as per the below image.

# How to complete Wholesale Sales Data Questionnaire

The questionnaire allows you to determine if you are exempt from the reporting requirements or if you are required to report your wholesale sales transactions.
